

1. Product and company identification

2. Description of the product

- **Intended use:** Gift bags and carrier bags for packaging, decoration and transport of light items.
- **Material composition:**
 - **Materials:** paper, plastic, textiles or combined materials.
 - **Surfaces:** Coated, painted, printed or structured.
 - **Additions:** handles made of cord, plastic or metal, adhesives.

3. Possible dangers

- **Risk of mechanical injury:** Sharp edges or poorly attached handles can cause injuries.
- **Choking Hazard:** Plastic parts or small components can be swallowed by children or pets.
- **Fire hazard:** Paper and plastic materials are highly flammable.
- **Chemical exposure:** Coatings, adhesives or printing inks can be harmful to health if they come into direct contact with the skin.

4. Safety instructions

4.1 General safety instructions

- **Keep away from children and pets, especially small parts or plastic.**
- **Keep away from open flames and heat sources.**
- **Not for consumption - purely decorative and functional purpose.**

4.2 Notes on use

1. Use carrier bags and gift bags only for their intended purpose.
2. Avoid overloading to prevent handles from tearing or breaking.
3. If there is visible damage or cracks, do not continue to use the product.
4. Avoid direct skin contact with coated surfaces if allergic reactions are known.

4.3 Storage instructions

- Store in a cool, dry place protected from light.
- Avoid moisture to prevent material damage.
- Store flat to avoid deformation.

5. First aid measures

- **In case of cuts caused by sharp edges:** Clean and disinfect the wound and seek medical attention if necessary.
- **If skin irritation occurs due to coatings or adhesives:** Clean skin thoroughly with soap and water.
- **If parts are swallowed:** Do not give food or drink and seek medical attention immediately.
- **If vapours are inhaled (e.g. adhesives):** provide fresh air; seek medical advice if symptoms occur.

6. Firefighting measures

- **Suitable extinguishing agents:** CO₂, foam, powder.
- **Special measures:** Wear respiratory protection when plastic or adhesive components are burning.
- **Note:** Burning paper or plastic can release toxic fumes.

7. Storage and transport

- **Storage:**
 - Store in a dry place and protected from moisture.
 - Protect from mechanical damage.
- **Transport:**
 - Stack products securely to avoid creases or tears.
 - Protect from heavy loads or excessive heat.

8. Disposal instructions

- **Material-dependent disposal:**
 - Paper bags: recycled paper according to local regulations.
 - Plastic carrier bags: Recycling according to local regulations.
 - Coated or combined materials: Dispose of via residual waste.
- Recycle packaging materials according to local regulations.
